This year in addition to the traditional Caring Kind Award, Excellence in Service and Trustee of the Year awards, the NHA Nominating Committee instituted a new award, the **Meritorious Service Award**, for the purpose of the association to recognize the long-term contributions of members to the association and their individual hospitals. This award is presented in addition to the NHA's highest award of honor, the Excellence in Service Award. The Class V graduates of the NHA Leadership Institute will also be recognized, as well as the Quest for Excellence awards. In addition, there will be a presentation entitled "The Richest Man in Town" by V.J. Smith.

It is my pleasure to request your nominations for these awards to be presented at the NHA Annual Convention on Friday, October 31, 2008, at the Cornhusker Marriott Hotel and Convention Center in Lincoln. The Caring Kind Luncheon is always one of the most anticipated events of the year as we recognize outstanding achievement in the award categories.

Caring Kind

Each NHA member hospital may select one recipient to receive the Caring Kind Award and the criteria are up to you. Past recipients have included hospital employees, trustees and volunteers from a wide variety of positions, but they all exemplify the teamwork, dedication and spirit that create a positive work environment and enhance patient care.

The honored employee will join me on the stage at the event to accept their award and have a picture taken. Excellence in Service

There are many hospital executives who benefit their communities through their commitment to health care excellence. The Nebraska Hospital Association has created the Excellence in Service award to recognize one hospital executive who has demonstrated outstanding administrative skills, professional performance, health care organization involvement and leadership.

Meritorious Service Award

The NHA Nominating Committee has initiated the Meritorious Service Award to recognize the long-term contributions of members to the association and their individual hospitals. This award recognizes longevity and breadth of service of an individual, not only to their facility, but to health care in the state. Nominees must be currently employed by a NHA member hospital or have retired from a NHA member hospital within one calendar year or less.

Trustee of the Year

This award recognizes outstanding leadership and hospital governance by a trustee. The recipient encourages commitment to excellence in health care and collaborates with community leaders to build support for their hospital. See the nomination form for more detailed criteria for this prestigious award. A review committee will select the Trustee of the Year recipient from the submitted nominations.
