Question 3

Membership Type – Hospitals

General Medical/Surgical – Dues Formula:

Hospitals that belong to a system are combined as one organization. Membership dues are calculated based upon operating revenue and the applicable rate is applied at the ranges below:

Range Number	Range Minimum (000)	Range Maximum (000)	Rate	Minimum Dues
Three	\$40,000	\$99,999	0.500	
Two	\$20,000	\$39,999	0.750	
One	\$0	\$19,999	1.000	\$5,000

Footnote	Description
A	Hospital systems are not assessed a separate dues fee. We combine all the operating dues revenue for a system, apply the dues calculation and bill the hospital system one membership dues amount.
B	No member of the Board of Trustees may serve more than three (3) two-year terms without at least one year absence from the Board of Trustees.

Associate Membership Dues Structure

Silver Level Associate Membership

Cost \$500 for organizations with five or fewer employees; \$1,500 for organizations with over five employees

Benefits:

- Opportunity to attend the OAHHS Annual CEO Retreat

- Limited access to OAHHS professional staff to request information and assistance in dealing with complex health care issues

Cost: \$5,000

Platinum Level Premier Associate Membership

Cost: \$9,500

Benefits:

 - Annual Meeting keynote speaker
 - Annual Meeting CEO dinner
 - Annual Meeting reception preceding CEO dinner
 - Golf tournament
 - Opportunity to submit political action committee fundraiser proposal to Oregon Hospital Political Action Committee for consideration and implementation. (Fundraiser may be combined with one of the events above)
- Two free registrations to OAHHS Annual CEO Retreat, including free participation in golf tournament if applicable
